

International students from countries outside the European Union must pay special registration fees in addition to their tuition fees, hence the following expected sums:

If you meet at least one of the conditions below, you will not have to pay a differentiated registration fee

NATIONALITY

- ✓ I am a student from the European Union, the European Economic Area (Norway, Iceland, Liechtenstein), Monaco, Andorra, Switzerland or Quebec.
- ✓ I hold a resident permit stating that you are the family member of an EU, EEA or Swiss citizen.

MY ENROLLMENT IN 2023/2024

- ✓ I'm a student enrolled in a CPGE ("Classe Préparatoire aux Grandes Ecoles") and in a Bachelor's degree from the Toulouse School of Economics (TSE).
- ✓ I'm a PhD or HDR student.
- ✓ I am a student with an apprenticeship contract
- ✓ I'm a student enrolled in a Master's program in the "International Track": [See the list on our website.](#)

MY ENROLLMENT IN 2022/2023

- ✓ I was enrolled in a course of the Toulouse Capitole University in 2022/2023

MY ENROLLMENT IN 2018/2019 or earlier

- ✓ Before the start of the 2019/2020 academic year, I was enrolled:
 - in a public institution of higher education under the authority of the French Ministry of Higher Education, Research and Innovation, at all levels (Licence, Master, Doctorat)
 - in a French as a Foreign Language (FLE) center

MY STATUS IN FRANCE

- ✓ I am a student with a long-term resident card
- ✓ I am a student who has declared his or her tax home or who has been attached to a tax home in France for at least 2 years as of January 1 preceding the start of the academic year for which registration is requested.
- ✓ I am a student with refugee or subsidiary protection status.
- ✓ One of my parents (or my legal guardian) has refugee status or subsidiary protection

FRENCH GOVERNMENT SCHOLARSHIPS AND EMBASSY EXEMPTION

- ✓ I'm a student on an exchange program or convention
- ✓ I'm a French government grant holder
- ✓ I benefit from an exemption from the French embassy in my country of origin

EXEMPTION FOR INDIVIDUAL ACADEMIC EXCELLENCE
